AGREEMENT

I, the undersigned, agree to the following terms while my rat(s), referenced above, are under the care of **Tiny Toes Rat Rescue of New Mexico (TTRR)**:

- I understand that **TTRR** expects me to pick up my rat(s) on the Pick Up Date specified and I agree to do so. I understand that I must contact **TTRR** via phone (505-263-2960) or e-mail (tinytoesrats@aol.com) if I need to change the Pick Up Date. I understand that if I fail to pick up my rats from **TTRR** by the Pick Up Date and fail to contact **TTRR** by seven days after the Pick Up Date, my rats will be considered the property of **TTRR** and may be available to others for adoption.
- I understand that when I drop off my rat(s) at **TTRR** I must provide their cage and a water bottle with a holder. **TTRR** will provide my rat(s) with a daily staple diet of lab blocks, fresh fruits and/or vegetables, and a cooked meal.
- I understand that **TTRR** requires a **\$20.00 CASH deposit per rat** to discourage abandonment of rats and that this deposit will be fully refunded to me when I pick up my rat(s) less all rat boarding charges.
- I understand that **TTRR** charges its rat boarding fee based on the following terms and fee schedule:

Terms

- The Drop Off Date counts as Day 1 for rat boarding charges.
- There is no charge for the Pick Up Date if the pick-up time is prior to 7:00 pm.
- The rat boarding fee is due in full in CASH on the Drop Off Date.
- If the rat(s) are picked up prior to the scheduled Pick Up Date, charges will only apply to the actual days the rat(s) are in the rat boarding care of **TTRR**.

Fee Schedule

- \$3.00 per day for one rat, \$4.00 per day for two to three rats, and \$5.00 per day for four or more rats.
- There may be additional charges for larger rat groups and when multiple cages are necessary because it requires more work for **TTRR** representatives.

- I understand that while **TTRR** will do everything in their power to ensure the excellent care, health, and safety of my rat(s), rats (like all animals) can experience a sudden onset of illness that may result in death; therefore, **TTRR** cannot possibly guarantee that my rat(s) will not develop illness, parasites, or die while in their care and is not responsible should this occur. Should my rat(s) become ill, **TTRR** will seek veterinary care for them (please see the separate Veterinary Care Authorization). In the event my rat(s) should die, his/her/their remains will be preserved by **TTRR** and turned over to me on the Pick Up Date.

VETERINARY CARE AUTHORIZATION

I, the undersigned state the following:

- I have contacted the veterinary clinics referenced on page one of the Rat Boarding Contract, authorizing them to treat my rat(s) if they are taken in for treatment by a **TTRR** representative.
- I have provided these clinics with my credit card number which all expenses for veterinary care will be charged to.
- I understand that TTRR will contact the veterinary clinics referenced on page one of the Rat Boarding Contract to verify that I have authorized treatment for my rat(s) and provided my credit card number.
- I agree to the following terms while my pet rat(s), referenced on page two of the Rat Boarding Contract, are under the care of **Tiny Toes Rat Rescue of New Mexico (TTRR)**:
 - I authorize **TTRR** representatives to seek veterinary attention for my pet rat(s), as they deem medically necessary, at the veterinary clinics referenced on page one of the Rat Boarding Contract.
 - In the event that the veterinary clinics referenced on page one of the Rat Boarding Contract are unavailable as needed, I authorize **TTRR** representatives to seek veterinary attention for my pet rat(s), as they deem medically necessary, at a veterinary clinic of their choice.
 - I will reimburse **TTRR** for all charges associated with veterinary care, prescriptions, supplies needed, and mileage traveled from their location to the veterinary clinic and back, at a rate of 15 cents per mile.
